I refer to your e-mail of 17th March 2025 in which you requested the following information:

I am writing to request the following information under Freedom of Information legislation:

- 3. The number of King's and Lord Treasurer's Remembrancer employees whose annual salary is £80,000 or higher.*
- 4. The number of King's and Lord Treasurer's Remembrancer employees whose annual salary is £100,000 or higher.*
